One of the worst hit sectors of the pandemic has been the travel and hospitality. Since March 2020, the tourism and hotel industry lost over 80% of its business, while the hotel industry alone recorded a loss of over RM6.53 billion in 2020*. While there is light at the end of the tunnel with the vaccination rollout and National Recovery Plan, the sector has a long journey ahead and many players may not survive the recovery period.

In Malaysia, 98.5% of business establishments are small and medium enterprises (SMEs) that contribute almost 40% to the country's GDP and employ more than 7 million workers*. According to the World Bank, Malaysia's SMEs have been underperforming in comparison to peer countries, in terms of output and productivity, even before the pandemic. Most notably, digital adoption among SMEs lag far behind with only one in three businesses implementing digital transformation strategies. The pandemic adversely impacted SMEs, and also highlighted the lack of readiness of SMEs to shift to an online environment, especially micro-businesses.

How can SMEs scale up their digitisation efforts, and what role can ministries and agencies like MITI, MEDAC, MDeC, and SME Corp play to future-proof the backbone of our economy, the SMEs? This session will explore this and other issues affecting the digitalisation efforts of SMEs with a view towards ensuring higher resilience against future shocks.

The retail sector, including malls, is one of the worst-hit sectors during the pandemic. Due to lockdowns, the retail sector contracted 16% in 2020, its worst performance since the 1998 Asian financial crisis, with double-digit contractions for apparel, footwear, and fashion accessories. Even hypermarkets, supermarkets, and convenience stores recorded a drop in total sales due to lower footfall. Online shopping, however, has seen a substantial increase in sales, with e-commerce revenues shooting up 30% in 1Q 2021 y-o-y, after registering steady growth in 2020*.

The statistics indicate the need to migrate to e-commerce. For shopping malls that rely on footfall, is there a way to combine the best of traditional retail and online shopping to enhance the customer experience and increase sales?

The pandemic caused disruptions in the supply chain as well as halted production across many sectors worldwide. The COVID-19 pandemic has triggered one of the worst jobs crises since the Great Depression, and ten times more devastating than the global financial crisis. There is a real danger that the crisis will increase poverty and widen inequalities, with the impact felt for years to come. Worst hit are young job seekers, especially fresh graduates, with youth unemployment among 15 to 24-year-olds at over 13% in Malaysia, more than five times the rate for older adults*.

This session addresses the trouble areas of employment in Malaysia, especially those that affect the nation's youth, and other employment gaps. The discussion will also cover future jobs hotspots and what policies are needed to ensure long-term job creation in the country.

Keynote Speaker, Closing Session

A medical doctor by training, Tun Dr Mahathir Mohamad, born in 1925 in Alor Setar, Kedah, became active in politics soon after the country's Independence in 1957. He was appointed Deputy Prime Minister in 1976, when Tun Hussein Onn became Prime Minister.

After Tun Hussein Onn stepped down in 1981, Tun Dr Mahathir bin Mohamad became Malaysia's fourth Prime Minister. He served the country for 22 years, becoming Malaysia's and South-East Asia's longest-serving Prime Minister. He led the country through a fast-paced modernisation drive that earned Malaysia international recognition as an industrial powerhouse. Under his leadership, several mega infrastructure-projects took place, notably the Kuala Lumpur City Centre (KLCC), PETRONAS Twin Towers, Kuala Lumpur International Airport (KLIA) and Multimedia Super Corridor (MSC). Tun Dr Mahathir opened Malaysia to foreign investments, reduced international trade barriers, privatised government services, as well as established world-class physical infrastructure.

During Tun Dr Mahathir's tenure as Prime Minister, Malaysia became one of the most prosperous and dynamic economies in Southeast Asia, with a thriving industry, growing middle class, and increased quality of life. Malaysia also played a more active role in the international arena, acting as a voice for developing countries in Asia and Africa. Tun Dr Mahathir Mohamad is also remembered for Vision 2020, a framework for making Malaysia a developed nation by the year 2020.

In 2016, Tun Dr Mahathir Mohamad set up a new political party to challenge the National Front. In 2018, making a stunning political comeback at the age of 93, the coalition he led, Pakatan Harapan, won the general elections and he was elected as Malaysia's 7th Prime Minister.

Dr Hishamshah Ibrahim is currently the Deputy Director General of Health (Research and Technical Support) Ministry of Health, Malaysia. He is also a Senior Consultant Paediatrician and Consultant Paediatric Haematologist and Oncologist where his clinical responsibilities and research interest include childhood malignancies, stem cell transplantation, haematological disorders and infections in the immunocompromised.

He received his professional degrees from the National University of Malaysia (Universiti Kebangsaan Malaysia) and his paediatric career has spanned positions in Malaysia, Australia, and the United States of America.

Besides formerly heading the Paediatric Department, he was also the Ministry's National Head of Paediatric Services charged among others with the clinical administration, training, planning and development of the paediatric clinical services for the whole country.

He was also an honorary lecturer and research supervisor for several post-graduate medical programmes of several universities and allied-health training programmes and has published numerous articles in peer-reviewed medical journals, book chapters and other medical papers. He is active in both industry and investigator-initiated research and has participated in presentations at medical conferences in Malaysia and internationally. He is an active member of several

Dr Jemilah is a medical professional with more than two decades experience managing crises in health, disasters and conflict settings. She is currently Professor and Director of the newly established Sunway Centre for Planetary Health in Malaysia. She had been the Special Advisor to the Prime Minister of Malaysia on Public Health, since April 2020 until August 2021. She is also a member of the Government of Malaysia's Economic Action Council, Climate Action Council and Consultative Council for Foreign Policy.

Her previous appointments include the Under Secretary General for Partnerships at the International Federation of Red Cross and Red Crescent Societies (IFRC), Chief of the World Humanitarian Summit secretariat at the United Nations, and Chief of the Humanitarian Response Branch at UNFPA. She is the founder of MERCY Malaysia a southern based international humanitarian organization.

Dr Jemilah has held many Board positions in NGOs and INGOs and is the recipient of numerous national and international awards for her work. In 2020, she was appointed a Senior Fellow of the Adrienne Arsht-Rockefeller Foundation Resilience Centre. She is currently on the board of the Employees Provident Fund of Malaysia and ALAM Foundation. Dr Jemilah is also the Pro Chancellor of Herriot-Watt University Malaysia and a member of the board of Universiti Kebangsaan Malaysia.

She graduated as a Doctor of Medicine (MD), has a Masters in Obstetrics & Gynaecology from the same university and is a Fellow of the Royal College of Obstetricians and Gynaecologists United Kingdom. She also completed executive education at the International Management and Development Centre, IMD Lausanne.

With a PhD in Public Policy from the Australian National University, Dr Hezri specialises in sustainable development solutions with work spanning areas such as green economy and natural resources governance. He has consulted for international organizations such as UNDP, UNESCAP, UNICEF, UNRISD and the World Bank, on many issues related to development and environmental challenges in the developing world. His past and current advisory roles include Cleared Advisor for the Malaysian Ministry of International Trade and Industries and a Member of the Advisory Council for WWF Malaysia.

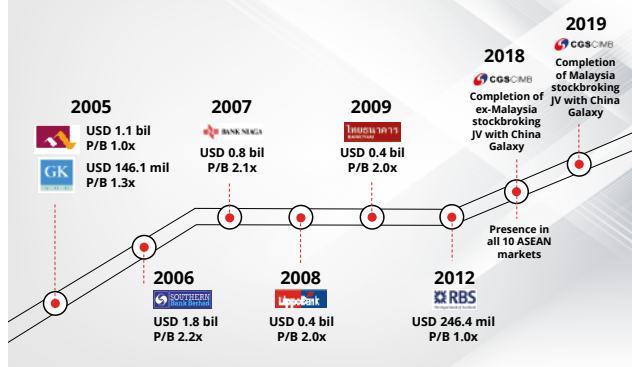

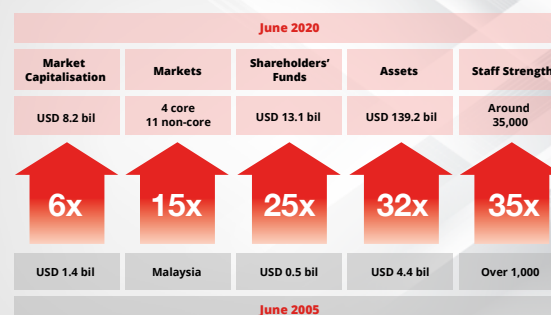

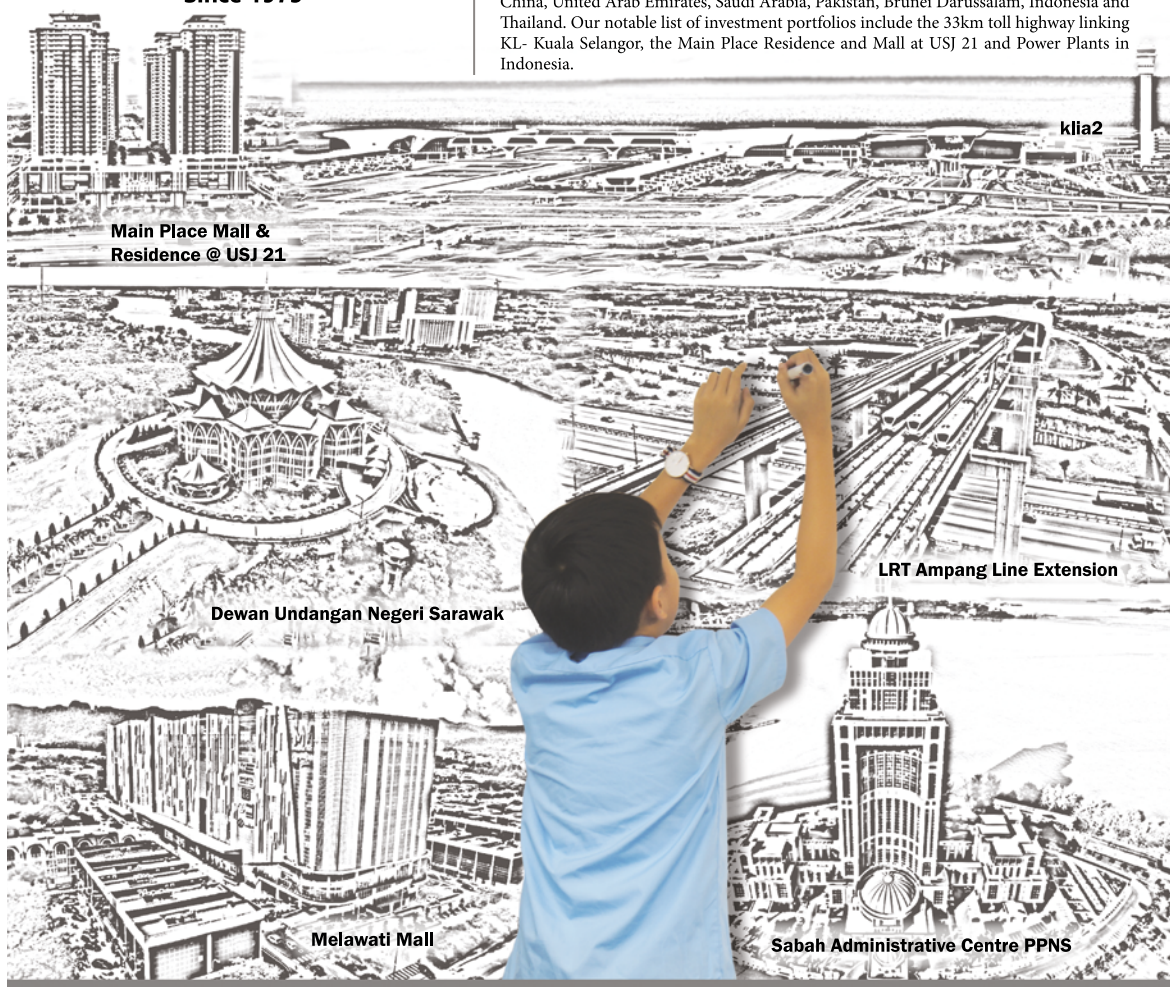

Kuala Lumpur Kepong Berhad (KLK) started as a plantation company in 1906 and until today, the development of oil palm and rubber remains the Group's core business. KLK presently has over 300,00 hectares of planted area for both crops. Our land bank is spread across Malaysia (Peninsular and Sabah), Indonesia (Belitung Island, Sumatra, as well as Central and East Kalimantan) and Liberia. In order to optimise value across the supply chain, KLK diversified into resource-based manufacturing (oleochemical, derivatives and specialty chemicals) in the 1990s by vertically integrating its upstream and downstream businesses. The Group, via KLK OLEO, has since expanded its manufacturing operations resulting in global oleochemicals presence in China, Indonesia, Switzerland, Germany, The Netherlands and Belgium.

In 1990, KLK started capitalising on the strategic location of its land bank in Peninsular Malaysia by branching into property development under KLK Land. Our first foray into property development was Sierramas in Sungai Buloh, a joint venture with Tan & Tan Development Bhd. It is currently focused on Bandar Seri Coalfields, a 1,001-acre township in Sungai Buloh, Selangor.

Perdana Leadership Foundation was established in 2003 with the aim of preserving, researching, and disseminating materials on, and by, Malaysia's past Prime Ministers. Premised on the belief that past leadership can yield valuable insights for present and future development, the Foundation's objective is to increase awareness and appreciation of Malaysia's history and leadership legacy.

The Foundation's physical home in Precinct 8, Putrajaya, was completed in October 2003. The stately building now houses the Perdana Library, an auditorium as well as a multi-purpose hall in addition to the office of the Foundation's Honorary President who is the country's fourth and seventh Prime Minister, YABhg Tun Dr Mahathir Mohamad.

The Foundation operates a physical and electronic library, the Perdana Library, which provides access to information on Malaysia's past prime ministers. The library collects, organises, and preserves materials by and about Malaysia's national leaders and events connected to them, with particular emphasis on the policies, strategies and initiatives they adopted. The Library contains almost

12,000 physical titles and more than 150,000 digital documents, comprising speeches, policy papers, and articles.

The Foundation's objectives are:

- To research, document, disseminate and publicise the intellectual legacies of Malaysia's past Prime Ministers.
- To create awareness of the development process of the nation and draw lessons from the nation's history to enhance future development
- To illuminate the contributions of Malaysia's past Prime Ministers in the social, economic, and political development of the nation.
- To be a resource centre of policies, strategies, and initiatives that were adopted under Malaysia's various Prime Ministers which may be used and adapted as models for the development of other nations.

The Foundation also has a broader objective which is to promote global understanding by providing a channel for scholars and thinkers to undertake research and idea-sharing for lasting, peaceful resolutions.
